

## Terms and Conditions for 10DLC SMS Registration

Effective Date: February 2nd, 2025

### Introduction

Welcome to Zion Trailer Rentals (“we”, “us”, or “our”). By registering for our 10DLC (435-669-9538) SMS services, you agree to comply with and be bound by these Terms and Conditions. Please read these terms carefully before using our SMS services. If you do not agree with these terms, you must not use our SMS services.

### 1. Eligibility

To register for our 10DLC SMS service, you must be at least 18 years old or the legal age of majority in your jurisdiction. By providing your information and opting in, you represent and warrant that you are eligible to use our SMS services.

### 2. Registration and Consent
